CLCA needs the following information from our members for our part in the registration process.

Transportation:

- I am driving to the event.

CLCA will reimburse members who drive to the event at the IRS rate of 51 cents per mile. CLCA also will reimburse for bridge tolls and any parking expenses in Sacramento.

CLCA HAS A NEW PROCEDURE THIS YEAR FOR MEMBERS FLYING TO THE EVENT. Members are required to make their own airline reservations to the conference. CLCA will reimburse for the cost of a ticket from a major southern California airport, but only up to the cost of such a ticket from Southwest Airlines for the lowest possible airfare as of March 25. This reimbursement will be sent shortly after the event and only if you actually attend it. CLCA suggests you make your reservation ASAP.
